History

Following the Civil War there has been continuous public activity on the 17 acre's, from a "Feeble Minded Home" to a home for widows and orphans of civil veterans. In 1921 the State purchased it for agricultural research where fruits and strawberries were developed and improved. In 2000 UC declared this property surplus, state law requires the state to offer it to public entities.

Recent History

Santa Clara's first BAREC public meeting was in front of the Planning Commission. Testimony was near unanimous to keep it open space. The Commission recommended preserving the 17 acres as open space

The first Council meeting to consider these recommendations ignored them, while unveiling a detailed plan developed by SummerHill Homes, complete with a token one acre park. These proposals were not mentioned at the Planning Commission meeting. Nor was the taking of public land for private use considered

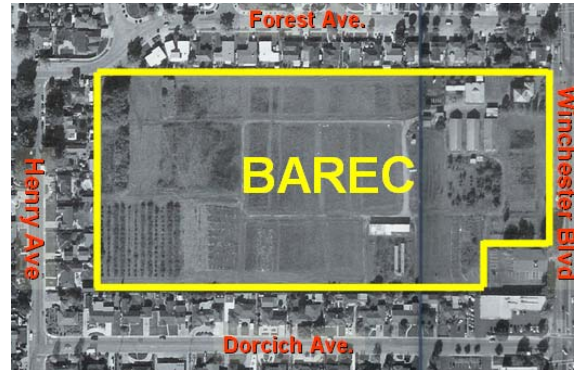
A majority of council members have accepted contributions from Summerhill Homes
